

In order to do so, you must file a written appeal within fifteen (15) business days of the mailing date of this letter. 65 P.S. 67.1101(a)(1). The appeal must include a copy of the RTKL request and agency's response, must state the grounds upon which the requester asserts that the record is a public record, legislative record or financial record, and must address any ground stated by the agency for delaying or denying the request. 65 P.S. 67.1101(a) (1).
